## **Treasurers Report:**

Financial statement to the end of March was presented by the Treasurer (copy attached). The Operational Account balance is \$48 525.71. Moved to accept the statement and accounts passed for payment by M Reynolds seconded by S Hodgson carried

#### **General Business:**

#### **COVID 19 Restrictions:**

Pigeon racing at this point of time cannot proceed under the current Government restrictions to contain the COVID 19 virus sweeping the country. The committee discussed the future of the QRPF under these restrictions.

- Moved M McCarthy seconded D Nester that the QRPF committee will continue to plan for racing if or when the restrictions allow and provide 4 weeks notice before starting racing. Carried.
- Membership fees: The QRPF is committed to the payment of certain costs whether we race or not. Moved J Profke seconded S Hodgson that in the event of no racing this year the actual cost of running the QRPF for the year will be calculated and membership fees will be used to cover this amount, the remaining funds will be carried over to next year to reduce the cost of each membership for next season. Carried.
- The committee has decided at this point in time to revise the start of the race season to the 27<sup>th</sup>
  June 2020. A draft revised race schedule is attached. This will be reviewed at the next
  committee meeting on the 4<sup>th</sup> May.
- Membership fees are due and payable by the 25<sup>th</sup> April 2020. Membership will lapse after this
  date if a member has not paid their fees.
- Flying fees will be revised if or when we start racing.

## Continue to train pigeons:

Members should continue to loft fly their pigeons to maintain fitness in the hope of racing at some stage this year.

#### Race Schedule:

If limited racing does proceed this season some suggestions have been put forward, such as having two or more races on the same day, which would allow members to send additional pigeons each weekend given that there will be more space available on the transporter.

Continue racing into October to extend the season etc. These issues can be discussed further if or when racing does go ahead.

#### J Amos LCPC:

J Amos has been given an eviction notice to vacate his current rental property and cannot race this year and has requested the return of his membership fee. A copy of the eviction notice has been provided. Moved J Profke seconded S Hodgson that this is granted. Carried.

## M & R Atkins PIC:

Verbal request to carry over membership fees to next season due to financial hardship. In line with the committee decision re membership fees, a portion of M & R Atkins fees will be carried over to next year.
