General Business:

National Race 2021:

The committee discussed the proposed National race in 2021 from the North. J Profke has spoken to NRC and there is general agreement to proceed with further discussion on details. Toowoomba flyers have expressed an interest in competing in this race. It was resolved to appoint Jeff Profke and Patrick Ketchell to further progress this proposal.

East Coast Long Distance Club (Sydney)

The above club is organizing a long-distance race for 2021 and is hoping to include Melbourne and Brisbane flyers in this event. The proposed race would be from a distance of at least 600 miles for each area. Each area would be responsible for arranging their transport to the release point, which is yet to be decided. The committee felt that members who have a particular liking for the distance races may like to get involved in this proposal, contact the secretary if you would like to be involved.

Toilets in Rod Hatherly Building

The toilets in the Hatherly building are badly in need of replacement. Jeff Profke has agreed to arrange for this work to be undertaken. The secretary is to discuss with the South Section the purchase of new toilets.

Race Schedule 2021

The committee will draft a race schedule for the North at the next meeting.

Toowoomba & Harvey Bay Transport:

They would like their birds released after the QRPF for all races except the last couple of long ones and the pick-up point will be at their clubhouse if feasible. A \$500 deposit is to be paid and arrangements made to get empty crates to them before the first race.

Harvey Bay are yet to confirm they are transporting with the QRPF but they have approval from our AGM for their birds to be released with the QRPF if they proceed.
