All PAYG Flyers must register their 40 birds by the 1 May 2021. The start of the second series these members will be able to top up with 20 birds at a cost of \$5 per bird. Multiple flyers at the same property will need to submit their bird registration lists to the QRPF Secretary before basketing for any race.
