## **8. General Business**

### **8.1 QRPF Ring Race**

M McCarthy would like notification put up on the Pigeon race net to remind members of the ring race. There is \$6200, 00 in prize money for the 2022 race from Morven. The QRPF has put a side 1000 rings for 2023 season which potentially could be \$10000,00 prize money. B Snyman will put updates on Pigeon race net and QRPF web page.

### **8.2 QRPF Appeals Tribunal**

M McCarthy would like that the QRPF have a tribunal committee to deal with any appeals submitted to the QRPF. The tribunal committee will consist of all the presidents of all Clubs in the QRPF. The management committee has agreed to take this to the AGM for further ratification.

## **APPEALS (2022)**

- 1) Competitors penalized under any flying rule of the QRPF by any committee shall have the right of appeal.
- 2) All appeals must be made in writing accompanied by a deposit of \$100 and received by the Management Committee within 14 days from the date of the penalty. The \$100 deposit will be retained by the committee should the appeal fail.
- 3) The Management Committee will convene a meeting with the competitor making the appeal within 14 days of receipt of such appeal at which time the competitor shall be given a full hearing and the case considered.
- 4) Competitors who fail with appeals to the management committee shall have a final appeal to a Special General Meeting of the members convened by the Management Committee within 14 days of being requested.
- 5) Majority support of the members attending the special meeting is required for an appeal to succeed.

### **8.3 Liberation Committee**

M McCarthy raised concerns about members providing info to outsiders and these outsiders publicly criticising the QRPF. The management committee would like to encourage members to rather raise any concerns with their Club secretary so these concerns can be addressed. The liberation protocols for the Dalby release on 3 July were followed. The only improvement the management committee would implement is that all three liberation committee need to communicate on a weekly base before liberation takes place.

### **8.4 Meadowbrook One loft Sponsorship**

Meadowbrook One loft has sponsored the first Mass Morven on the second series. The Fed winner will receive two free entries to Meadowbrook One loft intake in 2023. The management committee would like to thank Stevan Gazzola for his generosity.
